



## AACC Membership Package

### I. AACC Membership Background Information:

**Membership of the Afghan-American Chamber of Commerce (AACC) comes from all regions of Afghanistan and the United States as well as from other Central Asian market nations including: Dubai, UAE, India, Turkey and other nations.** Over 250 member organizations and individuals are represented by the AACC in its bilateral and regional program activities. Our membership is composed of:

- U.S. companies interested in trading, investing or doing business in Afghanistan;
- Afghanistan companies interested in trading, investing or doing business in the U.S.;
- U.S. companies owned by Afghan-Americans and doing business both inside Afghanistan and the U.S. or regionally; and
- Governmental, non-governmental, private, legal, academic and research organizations, institutions and individuals interested in U.S. - Afghanistan economic relations and Afghanistan's economic development as a market-oriented, private sector-led economy.

### II. AACC Membership Benefits:

**AACC Membership benefits are based on the particular "Membership Level" that each member selects. Generally speaking AACC membership benefits may include:**

- On-the-ground guidance for doing business in Afghanistan and the U.S. and business liaison and translation assistance with business leaders, government officials, and business and thought leadership networks;

- Guidance on financing and funding through agencies such as: The Overseas Private Investment Corporation (OPIC), IFC, Development Credit Authority (USAID), USTDA, World Bank, "Frontier Investors", Afghanistan Commercial Banks and Government Agencies, etc....
- Opportunities to contribute ideas and concerns directly to U.S. and Afghanistan Government officials, decision-makers, and U.S. Congressional and Administration policymakers in order to effectively promote a pro-business, pro-economic growth, pro-job creation economic reform agenda for Afghanistan;
- Access to members-only information and resources on the AACC website and through AACC leadership informational reports and e-newsletters;
- Providing important business and economic updates and key trade, investment and policy information about Afghanistan and the U.S.-Afghanistan economic relationship.

- **Basic-Student Membership:** \$50\* \* *Provide proof of enrollment in academic or vocational institution.*
